EXPLANATORY MEMORANDUM

The European Affairs Committee, through letter CLASS: 021-10/25-11/2, REF. NO: 6521-31-25-1 dated 23 May 2025, invited the parliamentary committees to submit to the European Affairs Committee notifications of new European Commission initiatives and the corresponding documents within their respective areas of competence, for inclusion in the Draft Work Programme for the consideration of the positions of the Republic of Croatia for 2025.

The document that served as the basis for drafting the Work Programme was the overview of initiatives and published documents from the European Commission Work Programme for 2025, which includes a total of 51 new initiatives divided into seven thematic areas.

Based on the above mentioned document, the following committees submitted their input to the European Affairs Committee regarding the initiatives and documents within their remit:

- Defence Committee
- Environment and Nature Conservation Committee
- Committee on Information, Computerisation and the Media
- Committee on the Croats Outside the Republic of Croatia
- Foreign Affairs Committee
- Agriculture Committee
- Gender Equality Committee
- Committee on Maritime Affairs, Transportation and Infrastructure
- Finance and State Budget Committee
- Domestic Policy and National Security Committee
- Health and Social Policy Committee
- Education, Science and Culture Committee
- Committee on Human and National Minority Rights
- Committee on the Family, Youth and Sports
- Committee on Regional Development and European Union Funds

The following committees reported that they had not identified any relevant topics in the overview of initiatives and published documents:

The committees proposed the inclusion of a total of 33 new initiatives from the European Commission Work Programme for 2025 in the Work Programme for the Consideration of the Positions of the Republic of Croatia for 2025. The Chair of the European Affairs Committee proposed the inclusion of 10 initiatives that had not attracted interest from the committees, and proposed the exclusion of five initiatives.

At its 14th session held on 27 June 2025, the European Affairs Committee discussed the Draft Work Programme for the Consideration of the Positions of the Republic of Croatia for 2025, which included the initiatives and documents as proposed by the committees and the Chair. Following the discussion, the Committee adopted the Work Programme for 2025.
