## What is Health Technology Assessment?

#### - "Health technology" comprises:

- medicines,
- medical devices,
- in vitro diagnostics devices,
- medical and surgical procedures, measures for disease prevention, vaccination, treatments - used in healthcare.
- HTA an evidence-based process that <u>assesses the</u> <u>added value (relative effectiveness)</u> of a given health technology/health interventions and compares it with other health technologies and / or the current standard of care.



## Health Technology Assessment (HTA)

**HTA assesses the added value (relative effectiveness)** of a given health technology over and above existing ones.

•Offers EU countries the chance to pool expertise


 New proposal for HTA post-2020 presented in January

•Next steps: discussion in Parliament & Council




#### Number of measles cases, EU/EEA, March 2018




# Burden of disease attributable to main risk factors 2013


### Fight Food Waste: no impact on safety of the food and feed chain
