In Focus

Commission Work Programme 2018: An agenda for a more united, stronger and more democratic Europe

Following the announcements made in President Juncker's 2017 State of the Union Address, the European Commission presented its plans for completing the work on President Juncker's ten political priorities before the end of its mandate, as well as a series of forward-looking initiatives for the future of Europe.

The focus of the 26 new initiatives in this year's Work Programme is two-fold. First, there are targeted legislative actions to complete the work in priority policy areas, which will all be tabled by May 2018 to allow the European Parliament and Council to complete the legislative work before the European elections of June 2019. Secondly, the Work Programme presents ambitious actions and initiatives that have a more forward-looking perspective, as the new Union of 27 shapes its own future for 2025 and beyond. These proposals reflect the debate kick-started by the Commission's <u>White Paper on the future of Europe</u> and President Juncker's <u>2017 State of the Union Address</u>.

To ensure a focus on delivery, the Commission Work Programme identifies 66 priority pending proposals presented in the past two years where swift adoption by the Parliament and Council is needed; the Commission also suggests to withdraw 15 pending proposals where there is no foreseeable agreement or they no longer serve their purpose or are technically outdated.

The Work Programme proposes a number of 15 proposals that follow on from regulatory fitness and performance (REFIT) reviews of current laws, taking into account the opinions of the REFIT Platform.

Effective application and enforcement of EU law by Member States will also be a priority, to ensure that citizens and businesses experience the intended benefits. The Commission will repeal three obsolete pieces of legislation.

Activities of the Croatian Parliament in the Decision-Making Process

Activities of the parliamentary committees

Three committees discussed European documents in accordance with the Work Programme for the Consideration of the Positions of the Republic of Croatia for 2017.

European Affairs Committee held its 20th session on 6 October 2017.

Labour, Retirement System and Social Partnership Committee held its 21st session on 25 October 2017.

Committee on Maritime Affairs, Transportation and Infrastructure held its 18th session on 27 October 2017.

Monitoring the work of the Government in the European Union institutions

The Croatian Government submitted to the relevant parliamentary committees its positions for the October Council meetings:

Application of EU law

In October 2017 the Croatian Parliament enacted 10 laws in the process of harmonization with European Union law.

EU Documents Forwarded Directly to the Croatian Parliament

According to the Protocol (no 1) on the Role of the National Parliaments in the European Union, all draft laws and communications shall be forwarded directly to the national parliaments.

The Croatian Parliament publishes on a daily basis the EU documents received, along with the information on: document number, adoption procedure, transmission date and subsidiarity deadline.

In October 2017 EU institutions forwarded to the Croatian Parliament 31 documents: 14 draft laws and 17 communications and other non-binding documents.

Inter-parliamentary Cooperation in the European Union

Inter-parliamentary cooperation in the European Union encompasses the cooperation between the European Parliament and the national parliaments and the cooperation among the national parliaments in the frame of the parliamentary dimension of the Council Presidency.


