OVERVIEW OF THE ACTIVITIES OF THE CROATIAN PARLIAMENT IN THE FIRST TEN YEARS OF CROATIA'S MEMBERSHIP IN THE EUROPEAN UNION (1 JULY 2013 – 30 JUNE 2023)

As the national parliament of a European Union member state, the Croatian Parliament participates in the management of European affairs, acting by virtue of powers granted to it by the founding Treaties of the Union and the Constitution of the Republic of Croatia, and in accordance with the Act on the Cooperation of the Croatian Parliament and the Government of the Republic of Croatia in European Affairs and the Standing Orders of the Croatian Parliament.

Since Croatia became a member of the European Union three years after the entry into force of the Treaty of Lisbon, the Croatian Parliament is the first national parliament to have built its own model of conducting European affairs based on the extended powers that the Lisbon Treaty conferred onto national parliaments.

The European Affairs Committee manages European affairs in accordance with the Act on the Cooperation of the Croatian Parliament and the Government of the Republic of Croatia and the Standing Orders of the Croatian Parliament, unless the Parliament decides otherwise.

Reporting on the meetings of the European Council

Once a year, at the beginning of the first annual session of Parliament, the Prime Minister submits a report on the meetings of the European Council held in the preceding calendar year, while during the year he submits reports on individual meetings of the European Council. After the debate on a submitted report, the Parliament votes on accepting or rejecting it.

In the first ten years of Croatia's membership in the European Union, the Croatian Parliament discussed nine annual reports on the meetings of the European Council with reference to the previous year.

Furthermore, over the years, 27 reports on individual meetings of the European Council were submitted, 16 of which were presented at the session of Parliament. After debate, the Parliament accepted the presented reports. The reports covered 64 meetings of the European Council.


Reporting on the meetings of the Council of the European Union

The Government reports to the Parliament on the positions of the Republic of Croatia for the meetings of the Council of the European Union in which the Government participates. These positions are delivered to the European Affairs Committee, which forwards them to the competent working body in line with the configuration of the Council. The European Affairs Committee may ask the Government to report on a meeting that the Council already held and on their preparations for a forthcoming meeting of the Council.

In the ten years of EU membership, the European Affairs Committee held 39 sessions in all, where the relevant ministries presented the reports on the meetings of the Council of the European Union that had already taken place and on their preparations for the Council meetings to come. In all instances, the European Affairs Committee held joint sessions with the working bodies of Parliament whose remits correspond to those of each Council configuration. Most of these joint sessions were held with the Foreign Policy Committee (12) and the Agriculture Committee (10), followed by those with the Finance and Central Budget Committee (5), the Judiciary Committee (4), the Environment and Nature Conservation Committee (4), the Committee on the Economy (2), the Committee on Maritime Affairs, Transportation and Infrastructure (1) and the Domestic Policy and National Security Committee (1). The Agriculture Committee held four independent sessions where it considered the reports from the meetings of the Agriculture and Fisheries Council.

Most of the abovementioned sessions were held in the first three years of Croatia's EU membership, i.e. in the 7th term of Parliament, when the reports on meetings of various Council configurations were discussed. In later years though, the reports discussed referred primarily to the General Affairs Council and the Foreign Affairs Council.

Consideration of the positions of the Republic of Croatia on draft legislative acts of the European Union

By considering the positions of the Republic of Croatia on the documents of the European Union, the Parliament controls the activities of the Government in the decision-making process in the Council of the European Union.

For the purpose of monitoring the Government's work in the Council of the European Union, the European Affairs Committee establishes an annual work programme for the consideration of the positions of the Republic of Croatia. The Government adopts its positions on the documents cited in the work programme, delivers them to the Parliament and the European Affairs Committee then forwards them to the competent working bodies of Parliament.

After debating the positions, the European Affairs Committee adopts conclusions based on which the Government acts in the Council of the European Union. If the Government departs from the conclusions of the European Affairs Committee, it shall notify the Parliament thereof.

The developments in the process of consideration of the positions can be followed in the <u>e-Doc</u> database managed by the Information and Documentation Department of the Croatian Parliament. The positions are published in this database along with related opinions of working bodies and conclusions of the European Affairs Committee.

From 1 July 2013 to 30 June 2023, the European Affairs Committee:

- adopted 11 work programmes for the consideration of the positions of the Republic of Croatia;
- submitted for consideration a total of 283 positions; and
- adopted 260 conclusions on the positions of the Republic of Croatia.

From 1 July 2013 to 30 June 2023, responsible working bodies of Parliament adopted 399 opinions on the positions of the Republic of Croatia.

Participation in the procedure of proposing candidates of the Republic of Croatia for the institutions of the European Union

The Croatian Parliament, through the European Affairs Committee, participates in the procedure of proposing candidates of the Republic of Croatia for the institutions and bodies of the European Union – the European Commission, the Court of Justice, the Court of Auditors and the Management Committee of the European Investment Bank.

The Government submits to the Parliament a report on a candidate of the Republic of Croatia for an institution or a body of the European Union. After holding a hearing with the candidate, the European Affairs Committee issues an opinion on the Government's report. The Government takes into consideration the Committee's opinion when adopting the final decision on the candidate. If the Government does not accept the Committee's opinion, it sends a written notification and explanation to the Parliament.

From 1 July 2013 to 30 June 2023, the European Affairs Committee participated in six procedures of proposing candidates of the Republic of Croatia for the institutions of the European Union and supported eight candidates proposed by the Government.


Directly forwarded legal acts of the European Union

Pursuant to the provisions of the <u>Protocol (no 1) on the role of national Parliaments in the</u> <u>European Union</u>, the EU institutions shall forward directly to national parliaments all draft legislative and non-legislative acts as well as other non-binding acts.

The Office for International and European Affairs daily publishes these documents in the <u>EU</u> <u>Documents</u> Section of the Croatian Parliament website, along with information on each act's reference number, adoption procedure, delivery date, subsidiarity check deadline, position of the Republic of Croatia, reasoned opinion and political dialogue, specification of the policy field and the title of the initiative in the Commission Work Programme.

In the period from 1 July 2013 to 30 June 2023, the institutions of the European Union directly forwarded to the Croatian Parliament 6,540 legal acts in the Croatian language.

Subsidiarity check and political dialogue between the European Commission and the national parliaments of EU member states

The Croatian Parliament participates in the decision-making process of the European Union by monitoring the compliance with the principle of subsidiarity in draft legislative acts and legislative acts of the European Union and by taking part in the procedures of amending the Treaties of the European Union and of implementing the *passerelle* clause.

Opinion exchanges in the framework of political dialogue between national parliaments and the Commission is another a form of direct participation in the decision-making process.

In the first ten years of Croatia's EU membership, the Croatian Parliament delivered to the Commission two reasoned opinions on two draft legislative acts in which noncompliance with the principle of subsidiarity was established. (In 2014, the proposal regarding the establishment of the European Public Prosecutor's Office; and in 2016, the proposal regarding the posting of workers.)

In the same period, the working bodies of Parliament delivered 17 submissions to the institutions of the European Union regarding different European and national topics, such as, among others, frozen meat consumption, support programme to provide fruit and vegetables to schoolchildren, organic production. Along with the European Affairs Committee, the Agriculture Committee is the one that most frequently made use of the institute of political dialogue.

Legislative alignment


The Croatian Parliament aligns the Croatian legislation with European Union law, in a procedure where all the bills by which this alignment is made bear the designation "P.Z.E.".

The Croatian Parliament adopts the annual plan for legislative alignment, which is an integral part of the Government's programme for the EU acquis incorporation and implementation and is the basic document in the process of incorporating and implementing European Union law into Croatian legislation.

All such legislation is published in the <u>e-Doc</u> database of the Information and Documentation Department of the Croatian Parliament.

From 1 July 2013 to 30 June 2023, the Croatian Parliament passed a total of 465 bills to align Croatian legislation with European Union law.


Interparliamentary cooperation in the European Union

Interparliamentary cooperation in the European Union is an instrument for national parliaments to coordinate and influence the decision-making process at the European level. It refers to the cooperation between the European Parliament and national parliaments as well as to the cooperation among national parliaments within the parliamentary dimension of Council presidency.

In the period from 1 July 2013 to 30 June 2023, the Croatian Parliament held the following meetings within the framework of interparliamentary cooperation in the European Union:

- 249 meetings organized by the EP and/or the national parliament of the member state holding the Council presidency;
- 14 meetings within the EU macro-regional strategies;
- 25 meetings within the Parliamentary Assembly of the Union for the Mediterranean;
- 43 other meetings (of which 13 in the context of the Conference on the Future of Europe);
- a total of 331 meetings.
